

"Providing emergency telecommunications services to the humanitarian community"

Republic of South Sudan Situation Report #12 Reporting period 15/06/12 to 12/07/12

## Summary:

• The Emergency Telecommunications Cluster continues providing data connectivity services to the Humanitarian Community in Renk, Maban, Pibor, and Bentiu while assessing user interest in view of the Humanitarian Internet Service Provider (HISP) project implementation.

## **Cluster Responsibilities:**

• WFP is leading ETC activities in RoSS with responsibility for coordination, implementation and overall operation support for common ICT services.

#### Achievements:

- The IT office kit ordered from WFP Somalia office is currently en route to RoSS and will be part of the ETC contingency stock.
- Consultations with the Local ETC Working Group regarding implementation of the HISP project have taken place. Malakal has been identified as the highest priority however discussions are ongoing with humanitarian organizations' managers regarding second priority to be Aweil or Bentiu.
- A HISP assessment survey is currently being conducted. NGO/UN agencies have been requested to send their feedback on the program and interest in subscribing by location to SouthSudan.ETC@wfp.org by 15 July. ETC has to date received significant positive response to the survey.
- An ETC mission was recently deployed to Yida to assist agencies with VHF Frequency usage and compliance.
- In Maban, ETC staff are assisting Save the Children with the installation of their VSAT. UNHCR and RI have already set up their own VSAT.
- UNHCR has installed a repeater in Bunj (Maban) providing security communications services. A radio room will be installed at the new UNHCR compound.
- ACTED has installed one repeater in Jemam (Maban) with the assistance of ETC staff.
- In Renk ETC support services are extended until the end of September. There are reports of humanitarian organizations departing the area.



• Additionally, Abyei has been identified by the HCT as a potential location for NGO/UN assistance. Therefore, the ETC is looking to supply Agok with a solution should it be prioritized (using the stock dismantled from Maban).

# Challenges and Gaps:

- The ETC Solution in Maban was scheduled to be removed at the end of June however it has been extended for an additional month due to significant need. It is now scheduled to be dismantled at the end of July.
- There are significant challenges with shipping and customs clearing delays with importing contingency stock. Additionally, due to the onset of the rainy season ETC is facing significant logistical challenges once the equipment is in country because of poor infrastructure.
- The Ministry of Telecommunications has indicated via newspaper advertisement that they will be requiring all VSAT users (UN and Foreign Missions exempted) to be registered with the authorities. ETC is currently following up and will continue providing information to Local ETC Working Group Members.

# Planned Activities:

- Following the agreement of the last ETC WG meeting and based on the assessment mission in Yida, Pibor will be dismantled on 15 July. The stock will be moved to the UNHCR compound in Yida to respond to the emergency there. The ETC solution in Yida will remain for three months.

- The Let's Com training will take place in Juba. Registration is now closed and humanitarian organizations technical staff will be confirmed their participation on 15 July. With agreement from the local ETC Working Group, the training has been postponed to August. The Local ETC Working Group participants requested the ETC Coordinator to look into the possibility of cost-recovery sessions to extend the training and allow more participation.
- The ETC response solution in Pibor is coming to a close on 15 July. Following the dismantling of the solution, the equipment is to be moved to Yida and will be installed by ETC.

#### Meetings:

The Global ETC teleconferences on RoSS will be held on an as-needed basis. Operational updates continue to be shared via monthly ETC SitReps.
