ETC Situation Report #25

Republic of South Sudan

#### **Highlights:**

• ETC continues to support three deep field locations (Kaya, Ajong and Jonglei State) with provision of telecommunications services. The HISP setup has commenced in Bor (Jonglei State).

## **Cluster Responsibilities:**

• WFP is leading ETC activities in RoSS with responsibility for coordination, implementation, and overall operational support for common ICT services.

#### **Achievements:**

- The ETC emergency response kit was successfully installed in Kaya (Upper Nile State) and the humanitarian community has been utilizing ETC telecommunications services as of 30 September.
- ETC has received additional funding in September bringing the 2013 budget to be 39% funded.
- After the arrival of the EMC team on 12 September, the equipment for the setup of the HISP was deployed to the first site, Bor, Jonglei State.
- A mission from FITTEST arrived in South Sudan on 29 September to conduct an assessment of the HISP setup in Bor and to run a diagnosis on all of the emergency kits in RoSS.
- UNHCR made two emergency response kits available for ETC to be deployed to emergency locations.
- ETC continues to provide support to organizations in terms of radio programming and basic IT support in Juba and in field locations.

#### **Challenges and Gaps:**

- Importation of telecommunications equipment continues to be a concern as significant delays are experienced in receiving tax exemption letters and customs clearance.
- The situation around Jonglei State remains tense and unpredictable and humanitarian access into many areas remains restricted.
- Funding remains an issue with shortfall of approximately 61%.



#### **Planned Activities:**

- Following the needs assessment conducted in Abyei in August, contingency planning is underway and resources are currently being mobilized for response.
- ETC is working towards an alternative power solutions (solar and hybrid) which will be sent to locations where emergency response kits are setup.
- Once the HISP is operational in Bor, the EMC team will travel to Aweil, Bentiu, Malakal, and Wau to setup the system.
- The CAP 2014+ process has commenced. ETC, in coordination with partners, has
  drafted the strategy for the next three years and will submit it to OCHA at the
  beginning of October.
- ETC continues to work closely with OCHA in order to finalize Cluster response plans for the Jonglei crisis.

## **Meetings:**

The Global ETC Teleconferences on RoSS will be held on an ad hoc basis. Operational updates continue to be shared via monthly ETC SitReps. Local ETC Working Group meetings are scheduled for the first Thursday of each month at 11am (UTC +3) in Juba.
