

# Republic of South Sudan ETC Situation Report #29 Reporting period 04/01/14 to 11/01/14

## **Highlights**

• In Mingkaman (Awerial County, Lakes State), ETC completed the setup of a mobile data connectivity kit which has supplied the humanitarian partners on the ground with basis data connection.

## **Cluster Responsibilities**

WFP is leading ETC activities in RoSS with responsibility for coordination, implementation, and overall
operational support for common ICT services.

#### **Achievements**

- On 10 January, an ETC mission travelled to Mingkaman (Awerial County) to set up a mobile data connectivity kit. The data kit is powered by a solar system and is fully operational. The services are available to all humanitarian partners currently operating on the ground responding to the influx of IDPs.
- ETC circulated a survey to all partners in RoSS on 11 January which aims to identify the needs of NGOs/UN agencies in light of the current situation. The deadline to complete the survey is 15/01/2014. Link to survey: https://www.surveymonkey.com/s/ROSSETCSurvey.
- As requested by the CHF Technical Secretariat, ETC revised the 2014 First Round Allocation CHF project proposal to respond to the current situation and reflect the needs included in the emergency response plan endorsed by the HCT.
- ETC provided technical support and equipment in order to establish data connectivity for an interagency conference room at OCHA in Juba which is utilized by many humanitarians actors, including all clusters.

### **Challenges and Gaps**

- Security telecommunications in Bor, Malakal and Bentiu were seriously affected due to radio operators
  relocating out of these locations due to security. A solution is being sought to make these radio rooms
  operational again 24/7.
- Due to the current situation in country, radio rooms across RoSS are understaffed; radio operator recruitment is currently underway.



#### **Planned Activities**

- The ETC data connectivity hub at the UN compound in Tomping is currently being finalized and will be
  operational in the coming days. An additional ETC solution will soon be setup at the remaining UN
  compound in Juba (UN House/Juba 3). These hubs will provide internet services to aid organizations
  responding to the IDP situation in these two locations, and will provide backup in case any organization
  needs to relocate there.
- In Juba, at the UNMISS base in Juba 3, ETC assisted the Logistics Cluster by installing a solar power and lighting system in the humanitarian hub which has been erected for the use of partners involved in the IDP response.
- An ETC mission to Mingkaman is being planned; the purpose of the mission will be to establish an
  internet café concept where the current ETC mobile data kit is located. This concept will provide an
  upgrade to the current basis solution which is being provided.
- On 13 January, an ETC mission will be travelling to Malakal to set up a mobile data kit in the UNMISS compound where many partners are operating from.
