## ETC Situation Report #15

## Reporting period 21/04/14 to 21/05/14

## **Highlights**

A radio repeater has been installed at Azraq refugee camp in Jordan, which opened on 30/04/14, to
provide radio coverage across the camp. Wireless and fixed internet is also available in the base camp for
use by ETC members.

#### **Cluster Responsibilities**

- The ETC in Syria is providing emergency telecommunications support to humanitarian organizations on the ground including VHF/HF radio programming and installation.
- Responsibility for the provision of ETC/common ICT services across the region is shared between WFP (Syria, Turkey and Iraq) and UNHCR (Lebanon and Jordan).
  - WFP is providing support to UNHCR telecommunications service provision if and when required.
  - WFP coordinates regional activities in close collaboration with UNHCR and other partners.

#### **Achievements**

- A budget revision is ongoing to align the budget with planned activities.
- The ETC is working on a submission for the 2014 SHARP mid-year review in order to provide updates to OCHA on ETC achievements, challenges and lessons learnt since the beginning of the operation.
- A Technical Agreement between WFP, UNDSS and UNDP to address the establishment of COMCENs and delivery of common radio services within Syria has been reviewed by the WFP legal team. It is now being reviewed by UNDP and UNDSS legal teams.
  - The Technical Agreement should improve delivery of radio services and the safety and security of humanitarian staff on the ground.

- An assessment mission to Aleppo was deployed at the beginning of May to assess the location of a proposed new UN hub, however a decision has yet to be made whether or not this hub will be established.
- An approval letter from MoFA regarding the importation of ICT equipment into Syria is still pending. It is unlikely this will be received soon due to the Syrian presidential elections in June, and Ramadan and Eid in July.
- A proposed location within Tartous has been identified for a UN hub. ETC services will be deployed in the hub once basic IT infrastructure is deployed.
- Radio programming for the humanitarian community in Syria is ongoing.

#### JORDAN

• A radio repeater has been installed at Azraq refugee camp, which opened on 30/04/14, to provide radio coverage across the camp. Wireless and fixed internet has also been installed in the base camp for use by ETC members.

#### IRAQ

- Almost all of northern Iraq has digital radio coverage.
- New radio handsets have been received and radio programming is ongoing with the assistance of UNAMI.
- Planning is underway to establish a new common radio room in Dohuk, North Iraq.

#### **Challenges and Gaps**

- The importation and licensing of equipment remains a problem in Syria.
- The volatile security situation continues to delay the assessment and installation of telecommunications capability for the humanitarian community in key areas within Syria.

## **Planned Activities**

- An audit of ETC activities will begin on 04/06/14. The ETC AMD and compliance processes have been updated in preparation.
- An additional radio repeater may be required in Dohuk city near the Domiz camp in Iraq to provide radio coverage.
- Radio operator and user training will be provided in Syria in June and July.
